- Instructional Rounds. The Fillmore Admin team received training with Admin teams from BOCES, Hinsdale, Belfast and Friendship on how to collectively evaluate instructional initiatives. All four districts worked together to assess an area of instructional focus in each school. At Fillmore, the area of focus was to measure the degree students are engaged in the learning process. It is a district goal to increase student engagement in the learning process. Feedback will be shared with teachers and will help to define action steps to meet the goal. Visiting administrators were impressed by the positive culture they witnessed while visiting classrooms.
