### 2. PROGRAMS/PRESENTATIONS -

- Paul Hedin of Clark Patterson Lee presented an overview of the draft plans for the cafeteria renovation developed by Carly Owczaczak which is part of the capital project. Items reviewed and discussed were flooring, lighting, wall treatments and seating. Food Service Manager Priscilla Beardsley was present to provide input.
- Also discussed were bids for the roof replacement, also part of the Capitol Project.
- The asbestos abatement for summer 2015 has been approved with that project going to bid after January 1, 2015.

# 3. DISCUSSION/WORK SESSION

- 3.1 Administrators' Reports
  - Dr. Butler reported that the Principals Challenge for reading was a success with students reading for over 856 hours. This resulted in Dr. Butler being the first Principal at FCS to kiss a pig! Both students and faculty attended the assembly which featured this epic event. It was a great way to engage students in reading and provide an exciting challenge.
  - The 1<sup>st</sup> qtr. Pre K 6 awards assembly was held November 14 with many students receiving recognition for academic accomplishments as well as attendance.
  - Faculty meetings have been going well with a variety of instructional strategies discussed.
  - Mr. Dodge commented on the leadership assembly that high school students attended. There was also an assembly that addressed internet safety.
  - The Annual National Honor Society assembly was held on November 12 with six students being inducted.
  - Lock down/lock out drills were performed with great participation. NYS Police were available to provide valuable input and recommendations. Mr. Dodge will review details of the drill at the next Safety Committee meeting.
  - And by the way, Dr. Butler kissed a pig!

  - Mr. Root provided an update on additions and alterations suggested by the architect for the upcoming Capital Project. Several were accepted and will be included in the scope of the project.
  - The Smart Schools Bond Act was passed giving FCS a \$933,542 grant for technology. Several items are under discussion, including implementing a one to one program. One to one means the school will provide a computer device for every student in grades 3-12. Students will use the device as a learning tool. The Safety Committee will also meet to discuss items that could be added or upgraded that would fit within the scope of the grant.
  - Mr. Root reported that the Fiscal Navigation classes he has been attending are going well and he has been gathering some valuable information as well as receiving confirmation that many of the fiscal programs that are currently implemented with in the district are on track with recommended practices.
