1. PRELIMINARY MATTERS/PUBLIC COMMENT

3. ADMINISTRATOR'S REPORTS

- 3.1 Principal Faulkner -
 - High School Principal Kyle Faulkner shared that the High School Play "A Family Reunion To Die For" will be performed on Friday night March 22 and Saturday night March 23 at 7:30 pm.
 - Plans are beginning for the 2013 graduation exercises which will be held on June 22 in the FCS Auditorium.
 - Winter sports season has come to a close with successful seasons by all teams. With 64 students participating on these teams, an overall grade percentage average of 89% was attained, continuing the tradition of academic excellence throughout our athletic program.

3.2 Principal Butler

Pre K-4 Principal Wendy Butler spoke regarding My Big Campus, a virtual learning experience
(VLE) program that is being considered. My Big Campus is a forum to organize curriculum and
help teachers and students collaborate, providing a safe virtual environment where all content
is filtered and monitored. Students have the opportunity to use tutorials, check on assignments
and journal. They can use the social media style platform discuss lesson assignments with class

5. DISCUSSION / WORK SESSION

5.2 Superintendent Root presented information and led discussion regarding maintenance of the athletic fields. There was discussion regarding the advantages and challenges of using commercial herbicides. A suggested schedule of maintenance, including over seeding, then herbicide application was discussed along with reporting that the total estimated costs would be in the range of \$13,000 to \$14,000. Several contractors will be contacted to provide estimates for all or part of the work. It was though that some of the work may be accomplished with current staff.

5.3 Superintendent's Report

- An MOA between the District and the CSEA unit was approved by the unit membership clarifying protocols on employees start times should a delay in the start of the school day be announced.
 - An updated 2013-2014 School Calendar was reviewed.
- Mr. Root shared a letter from Congressman Tom Reed sent to Secretary of Education Arne Duncan. The letter lobby's for increased federal funding to rural, high need districts in light of recent automatic spending cuts enacted on March 1, 2013 as part of the Budget Control Act of 2013.
- In an effort to continue our work regarding mission, vision, and roles Mr. Root will begin to speak with teachers for their input. This information will then be shared in a Board workshop setting to help gain a clearer picture of where we are, where we should be going and how to get there.
- Lynda Quick, current CA BOCES Asst. District Superintendent will be running for the vacant position of BOCS District Superintendent due to the retirement of Dr. Robert Olczak.
- Mr. Root encouraged Board members to read an article that discussed the relationship between NY State Gov. Cuomo, Common Core instruction and Pearson Education, which is under contract to provide NY State with standardized tests. - Safety Update. Contractors looked at the front main entry and interior doors. These interior front doors can be altered to create a small vestibule as a waiting space for single entry point access.

- Mr. Root will attend the BOCES annual meeting in Olean on April 10. Dinner is scheduled for 6:00 pm with the meeting to follow at 7:00 pm.
- Budget Presentations. Mr. Root reported that he has scheduled to meet with various community groups in an effort to accurately communicate the Districts 2013-2014 budget plan.

11.1 The following resolution was offered by Marcus Dean who moved its adoption and seconded by Sarah Hatch, to wit:

BOND RESOLUTION DATED MARCH 19, 2013, AUTHORIZING THE ISSUANCE OF \$217,900.00 SERIAL BONDS BY THE FILLMORE CENTRAL SCHOOL DISTRICT, ALLEGANY COUNTY, NEW YORK, PURSUANT TO THE LOCAL FINANCE LAW TO FINANCE THE PURCHASE OF TWO (2) 2013 THOMAS MODEL 11185 SIXTY-SIX (66) PASSENGER DIESEL SCHOOL BUSES.

WHEREAS, the Board of Education of the Fillmore Central School District, Allegany County, New York, by resolution duly adopted by the Board of Education on March 15, 2012, and approved by the voters of the Fillmore Central School District on May 15, 2012, authorizing the purchase of Two (2) 2013 Thomas Model 11185 Sixty-Six (66) Passenger Diesel School Buses, said buses to be purchased at a total price of \$217,931.60, and

WHEREAS, it is now desired to provide for the financing of said buses,

NOW, THEREFORE, BE IT RESOLVED AS FOLLOWS:

- 1. The purchase of Two (2) 2013 Thomas Model 11185 Sixty-Six (66) Passenger Diesel School Buses is hereby authorized at a maximum cost of \$217,931.60.
- 2. The plan for the financing of said buses is by the payment of \$31.60 from current budget appropriations, bus number 104 trade-in allowance of \$4,500.00, and the issuance of up to \$217,900.00 serial bonds of said School District, pursuant to the Local Finance Law, which bonds are hereby authorized therefore; further details pertaining to said bonds, if necessary, may be prescribed in another resolution or resolutions of this board.
- 3. Subject to the provisions of the Local Finance Law, the power to authorize the issuance of and to sell bond anticipation notes in anticipation of the issuance and sale of bonds herein authorized, including renewals of said notes, is hereby delegated to the

President of said Board of Education, the chief fiscal officer. Said notes shall be of such terms, form and contents, and shall be sold in such manner, as may be prescribed by said President, consistent with the provisions of the Local Finance Law.

- 4. It is hereby determined that the period of the probable usefulness of the aforesaid object or purpose is five years, pursuant to subdivision 29 of paragraph A of Section 11.00 of the Local Finance Law, and the said bonds will mature over a period not in excess of five years.
- 5. The faith and credit of said Fillmore Central School District, Allegany County, New York are hereby irrevocably pledged for the payment of the principal of and interest on said bonds as the same respectively becomes due and payable.
- 6. The bonds hereby authorized are declared to be "exempt bonds" under the provisions of the Internal Revenue Code of 1986 inasmuch as the Fillmore Central School District will not issue more than \$10,000,000.00 of bonds during the year of issue.
- 7. The validity of such bonds or notes or any bond anticipation notes issued in anticipation of the sale of such bonds may be contested only if:
 - i. Such obligations are authorized for an object or purpose for which the municipality, school district or district corporation is not authorized to expend money, or
 - ii. The provisions of law which should be complied with at the date of the publication of such resolution or summary thereof, or certificate, as the case may be, are not substantially complied with, and an action, suit or proceeding contesting such validity, is commenced within twenty (20) days after the date of such publication, or
 - iii. Such obligations are authorized in violation of the provisions of the constitution.

The resolution was thereupon declared duly adopted by the Chairman of the Board of Education, who directed the Board Clerk and Attorney for the School District to post and publish the notices related to the estoppel notice as required by law.

WHEREAS, the Board of Education of the Fillmore Central School district having the authority to levy and collect taxes for the Wide Awake Club public library (Education Law, Section 259) shall offer the following resolution to the voters of the district at the annual election on May 21, 2013:

RESOLVED: That the Board of Education of the Fillmore Central School shall be authorized to levy taxes annually in the amount of forty seven thousand, eight hundred dollars (\$47,800) and to pay said amount to the Wide Awake Club Library.

as may be necessary, shall be raised by tax on the taxable property of the School District to be collected in annual installments, and to issue obligations of the District therefore in accordance with Education Law and Local Finance Law.
